## REINSTATEMENT PETITION

**Notice:** This is the reinstatement petition to the Division of University College at IUPUC for Spring 2022 semester. No other semester's petition will be accepted.

If you were dismissed from another division (Business, Education, Liberal Arts, Nursing, Science) and plan to remain in the same major, you will need to contact that division to inquire about their reinstatement procedures. Do not use this petition.

**Not sure which petition to use?** Call University College at 812-348-7200.

**Overview:** Please carefully follow the directions below if you are petitioning for reinstatement to University College. The IUPUC University College Reinstatement Committee will review all completed petitions that are received by the deadline. Those incomplete will NOT be reviewed. Incomplete petitions are those with any missing information – including a missing response to even one of the six individual questions listed on pages 3 and 4. Students petitioning for reinstatement must demonstrate by their petitions that they have prepared themselves to have a reasonable chance of success in their study at IUPUC. If information outside of this petition is needed, or if a student has been dismissed two or more times, that student will be contacted to meet in person with committee members.

**Policy:** Students who have been dismissed from ANY campus of Indiana University are not eligible to enroll in any courses until they have been reinstated. By completing this petition, students may request reinstatement to IUPUC's University College (it does not matter which IU campus they were dismissed from, only that they wish to attend IUPUC now). Students who have been dismissed once are not eligible to apply for reinstatement until at least one full semester (fall or spring) has passed. Summer sessions do not count as a semester. Students who have been dismissed more than once are not eligible to apply for reinstatement until at least one full year has passed.

### **Submission:**

Before you submit this petition, it is your responsibility to make sure that you do not owe tuition and fees; financial holds on your student account preclude your ability to register and attend. Contact the Office of Bursar Services, CC 157 or at 812-348-7360 to inquire about any outstanding payments. Also, please consider your plan to pay for future tuition and fees should you be reinstated.

### Two Options:

1. Come to IUPUC's Office of Bursar Services, CC 157 to pay – and receive a receipt for payment of – a \$55 non-refundable fee. Take that receipt and your signed and fully completed petition to IUPUC's Division of University College located in CC 156H. Your petition will not be reviewed for completeness or accuracy. It will be accepted as presented.
2. Send your signed and fully completed petition via U.S. Postal Service mail, along with a \$55 non-refundable check payable to IUPUC to

Note that if you do not **fully** complete the petition, pay the non-refundable fee, or do not meet the appropriate deadline, your petition will not be reviewed by the committee.

**Deadline:** **For Spring 2022 semester reinstatement: Friday, October 29, 2021 by 5:00 p.m.** This is the date and time by which your completed petition must be received, not postmarked, by the Reinstatement Committee.

**Next steps:** You will be notified by U.S. Postal Service mail of the decision on your petition by **November 12, 2021**. If you are reinstated, you will meet with your probation monitor and/or your academic advisor to complete a reinstatement contract prior to being eligible to register for classes. Pay close attention to all deadlines. Please note that a reinstated student may have his/her class load limited, or may be required to take or retake specific courses appropriate to their major.

Be sure to respond to ALL six questions.**

1. Please explain **in detail** why your grade point average (GPA) fell below an acceptable level. Be sure to include relevant health issues, living arrangements, divorces, death of a family member, or other problems (academic or personal) that you encountered as a student that prevented you from being successful. If a medical problem was involved, please include a physician’s statement indicating to what extent your condition affected your academic performance.
2. Please discuss any obstacles or problems that you expect to encounter if reinstated. Be realistic. What steps have you taken or will you take to eliminate these problems? Please describe any other factors that you believe the individuals reviewing this petition should know. Describe why you feel you will be more successful in college if reinstated.
3. In many cases, the reinstatement committee will limit reinstated students in the number of credit hours they can take in their first semester. Even though students may be eligible for financial aid, receiving aid is dependent on the number of credit hours in which a student is enrolled. Please consider and then explain how you will pay for your first semester if reinstated with a limited course load. For the sake of this question, assume that no financial aid is available because your course load is under 6 credit hours.
